| <p>Summary:</p> <p>I left a message with a staff member for Dr. Walter to get back in touch with me about a preceptorship statement he had signed on behalf of Osteopathic Cardiology Associates.</p> <p>10:50 Dr. Walter called me back. We went over the new RSO requirements found in 10 CFR 35.50. Dr. Walter stated that he signed the preceptor statement because he believed that Kevin Mikielski, D.O. met the requirements found in 10 CFR 35.50(c)(2). I pointed out that the applicant was for a new license which had not been issued so Dr. Mikielski could not be listed "on the licensee's license," and that the doctor did not meet any of the other qualification requirements. Once the license was issued, Dr. Mikielski would meet the requirements of 10 CFR 35.50(c)(2). Dr. Walter stated that he would be willing to be an interim RSO and Authorized User for the licensee until an amendment was issued for Dr. Mikielski. I stated that I would pass that information along.</p> <p>11:45 I contacted Dr. Esper and informed him of the above. Dr. Esper agreed to speak to Dr. Walter and determine if the licensee would propose Dr. Walter or someone else as the RSO. I requested that in the written statement concerning the RSO, that the licensee also commit to having syringe shields for the administration of radionuclides. Dr. Walter indicated that syringe shields would be used and a statement added to the letter to propose a new RSO.</p> | | |
