

L. 102-589); 10 CFR Parts 15, 16, 170, and 171 (2000); Executive Order 9397 dated November 22, 1943; Debt Collection Improvement Act of 1996 (Public Law 104-134).
- 2. **PRINCIPLE PURPOSE(S):** To obtain taxpayer identification number / social security number / individual taxpayer identification number to enable the NRC to collect delinquent debts.
