10. Abstract The final rule establishes a National Source Tracking System to track sources containing radioactive material of concern. Although licensees already do so, Part 32 would establish a specific requirement for manufacturers to assign a unique serial number to each nationally tracked source. The system will use the combination of the manufacturer, model and serial number to track the sources.


The following is a summary of the topics, regarding the proposed collection of information, that the certification covers:
