SUBJECT: LICENSE AMENDMENT

Please find enclosed Amendment No. 03 to NRC License No. 46-27704-01 **adding Drs. Abate and Spyra as authorized users. We are unable to add Dr. Jenkins at this time. The documentation you supplied for Dr. Jenkins training and experience meets NRC requirements except for completion of Part II, "Preceptor Attestation" from NRC Form 313A. This form can be found on the NRC web site, [nrc.gov](http://www.nrc.gov) under "electronic reading room, document collections, NUREGS, publications prepared by nrc staff". Select NUREG-1556, Vol. 9, Rev. 1, Appendix B.**

**Dr. Jenkins will also need to meet the requirement for eluting generator systems specified in 10 CFR 35.290(c)(1)(ii)(G). This must consist of "hands on training" involving actual generator elution by Dr. Jenkins under the supervision of a preceptor. The preceptor could be an authorized user on the Heart Clinics Northwest license or any other authorized user listed on an NRC or agreement state license. To simplify the necessary documentation of this training, please have the preceptor note the generator elution training in the "Preceptor Attestation" (Part II) for Form 313A and complete all applicable portions of Part II. Upon receipt of this additional training documentation, Dr. Jenkins can be added to your license as an authorized user. Please refer to mail control number 470936 when submitting your documents and contact me at 925-673-9646 if you need assistance in completing the requested information.**

NRC's Regulatory Issue Summary (RIS) 2005-31, provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS. Pursuant to NRC's RIS 2005-31, the enclosed materials license will not be made publicly available.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14)(iv). You should review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or if you have any questions, please contact me at 925-673-9646.

In addition, please note that NRC Form 313 requires the applicant, by signature, to verify that the applicant understands that all statements contained in the application are true and correct to the best of the applicant's knowledge. The signatory for the application should be the licensee

or certifying official rather than a consultant. Since the NRC also accepts a letter requesting amendment of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
