Dear Mr. Spiro:

Please find enclosed Amendment No. 2 terminating License No. 45-25413-01 as requested by your letter dated April 24, 2006. On May 26, 2006, CTI, the company to whom you transferred the portable gauge, provided the NRC with a copy of the last leak test demonstrating that the sealed sources are not leaking. Therefore, this termination is being issued in accordance with the requirements of the applicable NRC License Termination Rule (10 CFR 30.36, 10 CFR 40.42, and 10 CFR 70.38) and all facilities previously used for licensed activities may be released for unrestricted use.

On March 22, 2006, the NRC issued a Notice of Violation (ADAMS Accession No. MI060810440) to you for failure to perform annual program reviews, failure to leak test the gauge every six months and for using an invalid UN number on the shipping papers when transporting the gauge on public highways. You have not responded to this Notice with the exception of requesting termination of your license. If you engage in licensed activities in the future, you must comply with NRC regulations, Orders, and license commitments. Failure to do so may result in escalated enforcement action.
