Enclosed for your information is the *Federal Register* notice for a proposed rule amending 10 CFR Parts 19, 20, and 50. The Nuclear Regulatory Commission (NRC) sent the Office of the Federal Register this proposed rule which amends the requirements for the reporting of annual dose to workers, the definition of the total effective dose equivalent (TEDE), the labeling of containers holding licensed material, and the determination of cumulative occupational radiation dose.

In § 19.13(b), the reporting of annual doses to workers would be limited to those whose annual dose exceeds the dose threshold of 1 mSv (100 mrem) for providing instructions to workers. This would result in the elimination of an unnecessary reporting burden. In §§ 20.1003 and 50.02 the definition of TEDE would be revised to be consistent with current Commission policy. Under the revision to § 20.1905, nuclear power licensees would not be required to label containers holding licensed material located in a posted area, if they are conspicuously marked and their accessibility is limited. Finally, the requirement in § 20.2104(a) that licensees attempt to obtain the records of a worker's cumulative occupational radiation dose would be removed.

These revisions would reduce administrative and paperwork burdens on NRC licensees without affecting the level of protection to either the health and safety of workers and the public or the environment.
