Agenda Item 4: Current Developments

The Secretariat will present the Status of a number of activities relevant to the work of the Commission. Under agenda item 4.1 the Secretariat will present proposals for future activities in order to continue with the momentum generated by the action plan for the development and application of the safety standards. In addition information on the request of COPUOS (Committee On the Peaceful Uses of Outer Space) and an update on feedback of experience on the safety standards will be provided. Under agenda item 4.2 the status of the review of the Basic Safety Standards and the plans for its revision will be presented. Under agenda item 4.3 the Secretariat will present the status the endorsed safety standards and response to actions from the eighteenth CSS meeting.

Agenda Item 5: The Use of the Safety Standards and Related Regulatory Issues

Under this agenda item the members of the Commission are requested to provide a short written report on their current regulatory issues and the use of the IAEA safety standards (current and planned) in their respective countries including any comparison of national regulations with the IAEA Safety Standards. Particular interest is on any difficulties observed in the national use or application of the IAEA Safety Standards and proposals for making the standards more readily adoptable to various national regulatory systems.

The Secretariat will present a provisional programme for the Senior Regulators' Meeting to be held during the General Conference.

Agenda Item 7: Report of the Committees

The Chairmen of the committees will report on their activities, plans and the important issues covered by the committees.

The safety standards approved by the committee(s) are discussed under agenda item 8. There will be presentations by the technical officers on the eight draft standards (one safety fundamentals, one safety requirements and six safety guides).

Agenda Item 9: Document Preparation Profiles

Document Preparation Profiles (DPPs) provide information on the scope and content of future safety standards. DPPs approved by the committees will be presented to the Commission for approval. There will be a short presentation by the technical officers on each of the nine DPPs for preparation of safety guides.
