Summary:	<p>I spoke to Dr. Havier on May 8, 2006 to ask for additional information showing evidence of training and experience of individuals requesting to be added to the license as authorized users. He stated he would get that information to me.</p> <p>I made a follow up phone call on June 8, as I had not received the information I requested. Dr. Havier informed me that the licensee no longer plans to pursue the amendment and that they in fact would be terminating the license soon. I sent Dr. Havier a reference to NUREG 1556 Vol 7 explaining the steps to terminate the license. I also informed Dr. Havier that he would need to submit a letter stating he would no longer wish to pursue the present amendment.</p>
