On March 2 and May 31, 2006, David Collins of this office conducted a safety inspection at the above address and the Asphalt Plant, Delmont, Pennsylvania of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selected examination of representative records. The findings of the inspection were discussed with Mr. P. Pavcik of your organization at the conclusion of the inspection.

Within the scope of this inspection, no violations were identified

The information provided in your correspondence dated August 25, 2005 was also examined as part of the inspection. This letter documents your corrective actions taken as a result of the inspection conducted of your facility on July 28 and August 18, 2005 (Inspection Report No. 03032127/2005001).
