This was the third heightened oversight call resulting from the April 2005 Illinois Integrated Materials Performance Evaluation Program (IMPEP) review. The review identified a number of regulations which were overdue for adoption. In June 2005, the Management Review Board found the Illinois program to be adequate to protect public health and safety but not compatible with the NRC's program. The Management Review Board determined that the Illinois program should undergo a period of heightened oversight until the State adopts regulations identified as overdue. The heightened oversight process involves State preparation of a program improvement plan, bimonthly conference calls, and submission of status reports.

The Illinois program improvement plan was submitted on August 10, 2005, identifying a tracking schedule for overdue regulations. A status report with an "IMPEP Milestones" table, was submitted on January 31, 2006, prior to the conference call.

During this conference call, the following items were discussed:

- Gibb Vinson discussed each of the regulations identified on the updated IMPEP
 Milestones table, which tracks the regulation process.
- John Zabko acknowledged the receipt of an Illinois regulation package submitted on January 31, 2006, which addresses regulations in Illinois Parts 310, 340, and 346. NRC staff will complete the review of these regulations by the end of March.
- Aaron McCraw stated that the IMPEP Milestones table compares favorably with the

Illinois State Regulation Status form maintained by NRC.

- Joe Klinger indicated that the remaining overdue regulations in Parts 330 and 335 are in process and will be submitted to NRC as soon as possible. Mr. Klinger emphasized that all overdue regulations are expected to be adopted, and approved by NRC, prior to April 30, 2006.
- John Zabko and Jim Lynch discussed the IMPEP follow-up review scheduled for June 6 and 7, 2006. The exit meeting with Illinois management will be on June 7th at 9:00 a.m. Janet Schlueter from STP, and either Steve Reynolds or Gary Shear from Region III, will represent NRC management at the exit meeting.
- The next heightened oversight call is scheduled for 1:00 p.m. (CT) on April 6, 2006. Illinois will submit a status update prior to the call. Jim Lynch will prepare a call agenda.
