Dear Mr. Bartle:

We are in receipt of your letter dated May 23, 2006, notifying us that you are no longer in possession of the Troxler moisture density meter and request a full waiver of the fiscal year 2006 annual fee for License 13-26166-01 (Invoice Number AM2941-06). Along with your letter, you provided supporting documentation confirming that the moisture density meter was sold to Andrews Engineering on April 11, 2006. Your letter states that due to budget constraints, your safety officer was transferred to a different department, which resulted in you submitting an untimely request to terminate the license.

The annual fee you were assessed for fiscal year 2006 covered the period October 1, 2005 to September 30, 2006. Licensees who filed termination requests prior to October 1, 2005, and who permanently ceased operations by September 30, 2005, avoided assessment of the fiscal year 2006 annual fee. Additionally, 10 CFR 171.17(b), provides that licensees who file termination requests and permanently ceased operation during October 1, 2005, through March 31, 2006, are assessed a fifty percent prorated annual fee invoice.

The Nuclear Regulatory Commission's Region III office terminated License 13-26166-01 on June 1, 2006, upon receiving your request on May 5, 2006. Based on your letter, I am granting you an extension of time to file for termination of the license to March 31, 2006. As a result, the invoice is revised to allow for a fifty percent prorated invoice. Revised Invoice Number AM2941-06 is enclosed for payment.
