By letter to the U.S. Nuclear Regulatory Commission (NRC) dated June 6, 2006, Nuclear Management Company, LLC (NMC), submitted an affidavit (CAW-06-2141) dated May 12, 2006, executed by you requesting that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390:

WEP-06-33 P-Attachment, "Transmittal of Figure 5-1 Reactor Coolant Temperature and Pressure vs. Time Level D Transients"

The document is included in Enclosure 3, "Low Upper-Shelf Toughness Fracture Mechanics Analysis of Reactor Vessel of Point Beach Units 1 and 2 for Extended Life Through 53 Effective Full Power Years, BAW-2467P, Rev.1, October 2004," to NMC's letter to the NRC dated June 6, 2006.

A nonproprietary copy (BAW-2467NP, Rev.1) of Enclosure 3 has been placed in the NRC's Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC. You also should understand that the NRC may have cause to review this determination in the future, for example, if the scope of the Freedom of Information Act request includes your information. In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
