We are inquiring as to the status of Brenda Christensen, MD as an authorized user of 10 CFR 35.200 materials for cardiovascular clinical procedures.


Summary:

1. At the Radiation Safety Committee meeting of 18 September 1997 (minutes attached), the credentials of Brenda Christensen, MD were reviewed (see item # 6) and it was the unanimous decision of the committee to name Dr. Christensen as an authorized user of Tc-99m for cardiac imaging.
2. In a letter to the NRC, dated 7 October 1997 (copy attached), the NRC was notified concerning our decision to add Dr. Christensen as an authorized user. Supporting documentation was also attached to this notice.


Information requested:

A quorum being established, the meeting of the radiation safety committee was Called to order at 11:00 AM on 18 September 1997.

1. The minutes of the previous meeting was reviewed and unanimously approved by the committee membership.
2. ALARA review: A review of the film badge reports over the last three months Indicates that all personnel are operating below ALARA level 1 guidelines.
3. QMP report: A quarterly review of compliance to the NRC's quality management program was performed by the medical physicist for nuclear medicine. Over the preceding three month period, 100% of the cases were reviewed. A copy of his report is attached. The radiation therapy department reported that, for the use of Cobalt 60, they plan to audit the program only on an annual basis on or about March 1998.
4. NRC Documentation: The following NRC documents were reviewed by the RSC:
 - IE 97-61: US DHHS letter re: year 2000
 - FR 39058: Radiological criteria for license
 - FR 40975: License term for medical use licenses
 - FR 42948: Proposed regulation – withdrawn (10 CFR 20)
5. The use of lead aprons in the OR as regulated by NJ-DEPE was discussed. It was determined that a physician user is in need of a specially designed lead apron. It was reported that this apron is on order.

6. The credentials of Dr. Brenda Christensen were reviewed. Dr. Christensen is seeking permission from this committee to be an authorized user of NRC licensed materials for the specific use of cardiac imaging. It was the unanimous decision of the committee to name Dr. Christensen as an authorized use of TC- 99m products for cardiac imaging. The NRC will be so notified.

It is noted that a license amendment was submitted to the NJ DEPE to add Dr. Christensen on our license as a authorized user of T1- 201 for cardiac Imaging. The NJ-DEPE approved her and a license amendment was issued.

7. I-125 prostate seed implants: A meeting is to be scheduled between the medical therapy physicist, Carrier (nuclear medicine) and Dan (radiation therapy) to review and finalize all I-125 implant procedures. The first safety lecture for OR is scheduled for Thursday, 24 September 1997.
