This refers to the May 23, 2006 meeting conducted at our request at the New Horizons Fellowship Annex, located at 820 E. Williams St. (Highway 55), Apex, North Carolina. The NRC Region II Chief of Reactor Projects Branch 4 and the NRC Region II Shearon Harris Nuclear Plant Senior Resident Inspector met with Carolina Power and Light Company (CPL) (Progress Energy - Carolinas) management to discuss the NRC's Reactor Oversight Process and the NRC's annual assessment of Shearon Harris safety performance for the period of January 1, 2005 - December 31, 2005 (CY 2005). Other attendees included 3 NRC and 19 Progress Energy-Carolinas management and staff members, 6 local TV and newspaper personnel, and 47 members of the public.
