Have you or anyone in Meadville had a chance to read through this Environmental Assessment from the NRC yet. It sounds like this issue has already been looked at by someone in the region prior to this becoming an NRC issue. I have looked through it from a radiological standpoint, and it really is not a change from their current approach. The only difference is the potential impact of excavating in a wetland, and that has no radiation dose consequence. If you can, please let me know if anyone has looked at it or is planning to take a look. As Bob stated NRC has asked for a quick turnaround on this. We usually try to accommodate them if we can. Especially if it has the potential to greatly hinder cleanup activities. And if you just need more time, I will call NRC and tell them that we need more time to provide an adequate response.
