Dear Mr. Snell:

The Oak Ridge Institute for Science and Education (ORISE) received 21 water samples, Batch One, on June 2, 2006 which were collected in the vicinity of the Clinton Station in Clinton, Illinois. The 21 water samples were analyzed for tritium using a liquid scintillation analyzer. The chain of custody identified four water samples to be analyzed by gamma spectroscopy (GS). The sample identifications and collection data are presented in Table 1. The GS data are presented in Table 2. The tritium data are presented in Table 3. The pertinent procedure references are provided in the specific tables.

ORISE's Quality Control (QC) requirements were met for these analyses. The QC files are available for your review upon request.
