I am responding to the electronic mail message from Mr. John Kerr of your staff, dated May 9, 2006, concerning Nuclear Regulatory Commission (NRC) involvement in the biennial International Training Course on State Systems of Accounting for and Control of Nuclear Materials (ITC-SSAC). NRC is familiar with this program, and delivered presentations during the course for a number of years. While in recent years NRC has only delivered one presentation on the U.S. SSAC, we are open to further involvement, as appropriate, consistent with availability of appropriate staff and the venue of the course.

NRC appreciates the National Nuclear Security Administration's (NNSA) contacting NRC to ensure interagency alignment on this request. As previously indicated during several recent phone conversations with Mr. Kerr, the NRC staff does not plan to actively promote or provide staff support for ITC-SSAC visitors to NRC licensee facilities in general, or to the University of Missouri facility in particular. NRC will also not make an assessment about the merits of the practical course exercise. Even in the context of a U.S. Government-sponsored international training course, the decision to grant access to visitors is the responsibility of the licensee. The NRC intends to remain neutral with regard to this request, and any others of this nature which NNSA may co-host with the International Atomic Energy Agency in the future. Therefore, you are free to address this planned visit directly with the management of the licensee. NRC staff has notified the University of Missouri of the NRC position concerning this request.
