SUBJECT: SUMMARY OF May 17-19, 2006, PUBLIC MEETING AND WORKSHOP
ON DRAFT REGULATORY GUIDE (DG-1145), COMBINED LICENSE
(COL) APPLICATIONS FOR NUCLEAR POWER PLANTS
(LIGHT WATER REACTOR EDITION)

On May 17-19, 2006, the Nuclear Regulatory Commission (NRC) staff met with approximately **85 combined license (COL) application stakeholders in a public meeting and workshop** to discuss the development of the draft regulatory guide (RG), DG-1145, "Combined License Applications for Nuclear Power Plants (LWR Edition)."

The staff discussed the development of Section C.III.1, "Information Needed For a COL Application Referencing a Certified Design" of the RG. The staff also addressed the Standard Review Plan update process. The staff also discussed specific sections of the RG that have been placed on the NRC web site as work-in-progress documents:

- (1) Section C.I.10, "Steam and Power Conversion;"
- (2) Section C.I.11, "Radioactive Waste Management;"
- (3) Section C.I.13.1, "Organizational Structures;"
- (4) Section C.I.13.2, "Training;"
- (5) Section C.I.13.3, "Emergency Planning;"
- (6) Section C.I.13.4, "Operational Programs;"
- (7) Section C.I.13.6, "Security;"
- (8) Section C.I.16, "Technical Specifications;"
- (9) Sections C.I.17.4 and C.I.17.5, "Quality Assurance;" and
- (10) Section C.I.17.6, "Maintenance Rule."

The staff from the Division of New Reactor Licensing and Office of General Council discussed the environmental portions of the RG. The industry has concerns with the level of finality of an early site permit. During the discussion the industry raised two key issues. One of the issues raised was whether the early site permit application and the combine license application are connected actions under the national environmental policy act (NEPA). The industry believes these actions are connected and that the NRC is not required to prepare a separate

environmental impact statement for issuance of the combined license. The other issue that was raised during the discussion is the information that needs to be included in an environmental report submitted with a combined license application that references an early site permit. The industry believes that only new information that is significant, as determined by the applicant, should be included in its environmental report included with a combined license application. The attorneys from the Office of General Counsel presented a rationale as to why they should be considered separate major federal actions. The staff has not taken a final position on whether the early site permit application and combined license application are connected actions.

The staff solicited comments and questions throughout the meeting. Questions submitted to the staff on DG-1145 will be posted on the NRC website. It is the staff's intent to develop responses to these questions and compile all the questions received prior to the issuance of DG-1145 for review and comment. The questions will be published in Section C.IV of the draft RG.

Breakout Session: Instrumentation and Controls (I&C)

A breakout session was held to facilitate public comments on the potential update topics for the instrumentation and controls related portions of the Standard Review Plan. For each I&C section the NRC presented topics that had been identified as areas to be considered for potential update. The public was asked to provide comments on additional topics that should also be considered for potential update of each I&C section.

Industry representatives also presented several issues outside the framework of the SRP update agenda about which they want to continue a dialog. These issues include (1) bidirectional communication between computers in different safety channels or between computers in safety channels and non-safety channels, (2) refinement of the cyber security criteria in Regulatory Guide 1.152, Revision 2, "Criteria for Use of Computers in Safety Systems of Nuclear Power Plants," and (3) adjustment of technical specification surveillance based on self-testing or monitoring.

Additional public meetings are planned to discuss sections of DG-1145. Future meeting notices will specify the dates and specific sections of DG-1145 to be presented and discussed.
