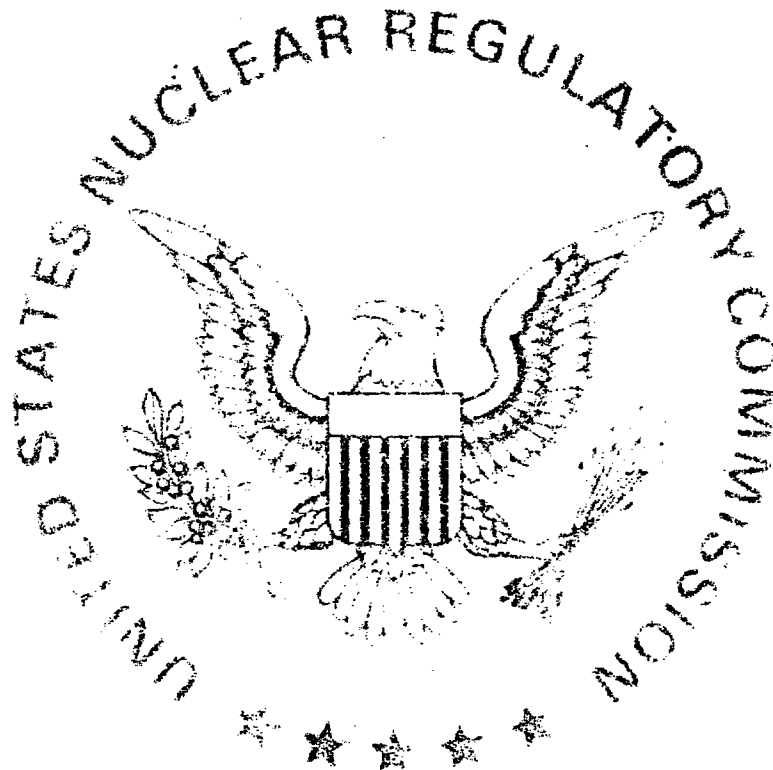

I asked the activity removed he did not know of Rand but indicated it was slightly leaking. I asked if he had notified the NRC when the source was determined to be leaking he believes the physicist did. I told him that the 12/10 letter referring to disposal is all I have. I informed him that I will terminate the Co-60 license but Mr. Cahill had the nuclear med. license action and that when RAM is removed he must perform a close out survey for our review. I told Tim Dwyer of 12/10/92 letter + he is very source incing we decide to perform our own survey before we terminate the N.M. license
