POWER REACTOR SECURITY REQUIREMENTS (SECY-06-0126)

The Office of Nuclear Security and Incident Response (NSIR) is providing, for information purposes, the enclosed rulemaking package to the Advisory Committee for Reactor Safeguards (ACRS). Previously in correspondence with the Commission (ADAMS accession ML051800350), the EDO authorized that ACRS review of the proposed power reactor security requirements would be deferred at the proposed rule stage, but would be retained at the final rule stage. Therefore, the attached proposed rule is being provided at this time for information purposes only.

The proposed rulemaking would amend the current security regulations and add new security requirements pertaining to nuclear power reactors, and would add new security requirements for Category I strategic special nuclear material (SSNM) facilities for access to enhanced weapons and firearms background checks. This rulemaking includes new security requirements for safety/security interface to which your specific attention is requested. Additionally, the proposed safety and security requirements contained in the proposed rule would address, in part, a Petition for Rulemaking (PRM 50-80) that requested the establishment of regulations governing proposed changes to facilities which could adversely affect the protection against radiological sabotage
