

MATERIALS LICENSE

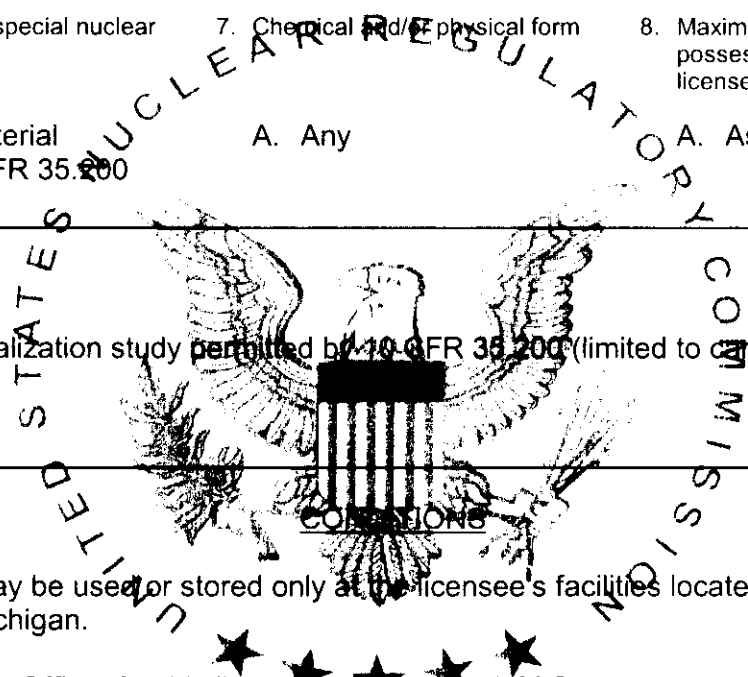

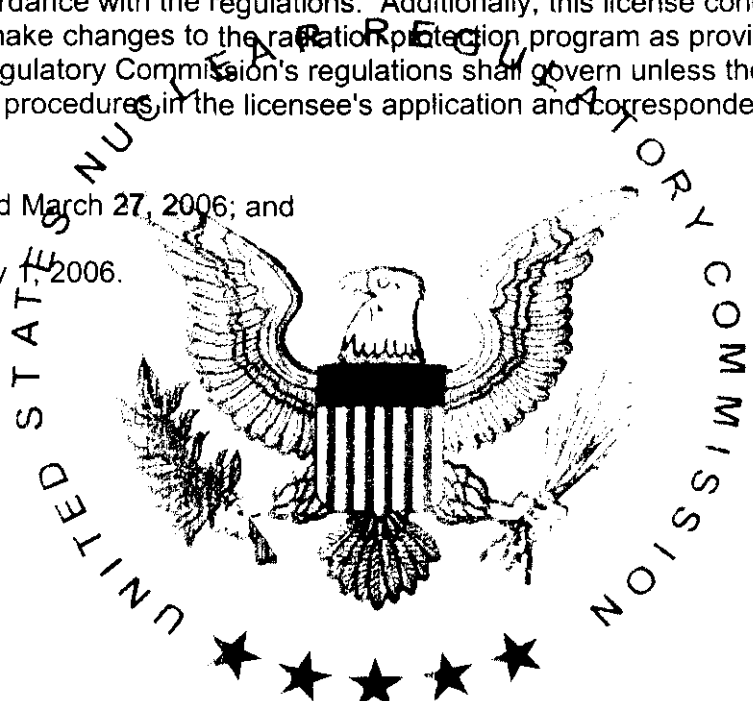
