SUBJECT: LICENSE AMENDMENT

Please find enclosed Amendment No. 32 to NRC License No. 11-27312-01 **deleting two authorized medical physicists and adding Clarissa Wright, MS, in condition 12.D as requested. As discussed with you by telephone on June 23, 2006, the listing of Dr. Wimmer as an authorized medical physicist on your license is pending the receipt and approval of preceptor and attestation NRC Forms 313A documenting Dr. Wimmer's training and experience with high dose remote afterloading devices. Please refer to Mail Control No. 470976 when submitting this information.**

NRC's Regulatory Issue Summary (RIS) 2005-31, provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS. Pursuant to NRC's RIS 2005-31, the enclosed materials license will not be made publicly available.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14)(iv). You should review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or if you have any questions, please contact me at 925-673-9646.

In addition, please note that NRC Form 313 requires the applicant, by signature, to verify that the applicant understands that all statements contained in the application are true and correct to the best of the applicant's knowledge. The signatory for the application should be the licensee or certifying official rather than a consultant. Since the NRC also accepts a letter requesting amendment of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. The NRC no longer publishes the NRC Rules and Regulations loose leaf supplements due to budget constraints.
