By letter received in the U.S. Nuclear Regulatory Commission (NRC) Region I office on April 12, 2006, you requested an amendment to your NRC License No. 10-25362-01 to change the point of contact and address of your license. Due to your change of address, the responsibility for your license was moved from NRC Region I to NRC Region IV jurisdiction. Therefore, your NRC license no. 10-25362-01 is terminated. You were authorized a new NRC license no. 05-29228-01, effective June 19, 2006.

The NRC staff has reviewed your historical file and determined that you were only authorized for temporary job sites. Therefore, there was no radioactive material located in facilities with in NRC jurisdiction. No further actions with respect to NRC regulated materials for this license is required and NRC license number 10-25362-01, with a mailing address of Alpharetta, Georgia 30022, is hereby terminated.
