





Comments from Commissioner Merrifield on COMSECY-06-0030:

I approve the renewal of the Advisory Committee on Nuclear Waste (ACNW) Charter with the provision that the estimated annual direct cost of this committee be revised to the correct figure. This report is on a schedule out of sequence with the budget and uses different input data (i.e., actual vs. budgeted values, etc.). Thus the derivation of the resources in the report is not transparent. Data is rolled up from other sheets which are not provided with the COMSECY. After being briefed by the staff, I am convinced that the financial data is consistent with the budget. However, when the report is submitted in the future, staff should provide an appropriate enclosure which provides the basis for the resource information in the report.




