SUMMARY

We have reviewed your letter dated March 18, 2006, requesting an amendment to your byproduct materials license and find that we need additional information as follows:

1. The attachment you said you had enclosed in request 2.9. was not enclosed. If you wish to add the cadmium-109 source/device as a line item, please submit the attachment. If you would rather obtain this source/device under your broad scope authority, the attachment and an amendment will not be necessary.
2. Under request 3, there is no amendment to Condition 23 that is appropriate and you have not asked me to change anything in Condition 23. You also did not tell me what you want to have changed in Condition No. 20.

In discussing this on the phone, it appeared that Jack intended for me to delete the "holding waste for ten half-lives" restriction from Condition No. 20 and I would also add the "less than **or equal to** 120 days" language in the condition, per the RIS 2004-17, Rev. 1.

Jack will clarify his intentions to me in a written response.

Under request 4, I didn't see anything being asked of me to amend on the license. Jack will likely withdraw this section.
