PURPOSE: Sidebar meeting to discuss the status of the soil decommissioning plan review, Pond 2 cell design review, and future submittals.

BACKGROUND:

DISCUSSION:

1. Environmental assessment (EA) and *Federal Register* (FRN) notice for soil decommissioning plan are in concurrence with the Office of the General Counsel.
2. Review of Pond 2 will commence starting July 2006.
3. Rio Algom will request change to the Pond 3 cover design to eliminate redundancy in the number of filter layers. Rio Algom will also request a change to the erosion protection near the tailings impoundment.

ACTIONS:

- NRC to complete soil decommissioning licensing action (EA, FRN, Technical Evaluation Report) in July 2006.
- Rio Algom plans to submit two license amendment requests in July 2006.
