✦ Reorganized last year from a unit into the Radiation Management Program,

• Radioactive Materials Unit:

- Licensing
- Inspection
- Incident Response

• X-Ray and Machines Unit:

- Certification
- Uses Qualified Inspectors for most machines
- MQSA

✦ Just finished successful IMPEP review.

License Terminations

✦ Hecla-Durita:

- ✦ CRR turned in for review 2005,
- ✦ DOE submitted LTS Plan to NRC – 2005,
- ✦ NRC raised questions about gw monitoring (or lack thereof),
- ✦ Ongoing discussions and field visits.

License Terminations (Cont.)

✦ Maybell

- ✦ CRR turned in Spring 2006,
- ✦ Under review at NRC,
- ✦ Should be no issues.

Remediations

✦ HWY 141 at Uravan:

- ✦ CDOT owned property,
- ✦ Removed ~ 50,000 cy,
- ✦ Disposed at UMETCO.

Remediations (cont.)

✦ Gateway Vanadium Mill:

- ✦ Orphan site,
- ✦ AEA license never terminated,
- ✦ Residents exceeding public dose limit,
- ✦ NRC funding obtained,
- ✦ Materials also into Umetco,
- ✦ ~ 14,000 cy of material moved.



Remediations (cont.)

✧ CSMRI Creekside:

- Legacy site,
- Indigent licensee (but really CSM),
- Numerous contractors,
- CSM wants cost recovery, so is following OSWER,
- License and D&D plan in place,
- Classification and disposition of material at issue,
- Lack of trust,
- Legal actions,
- Governor's Office mediating some issues.

Remediations (cont.)

✧ CSMRI – Table Mountain:

- ✧ Outdoor areas complete,
- ✧ One building at issue,
- ✧ Under renewal.

✧ AMAX R&D

- ✧ Remediation complete 2005,
- ✧ License termination request pending.

UMETCO/Uravan

- ✦ Remediation complete this month,
- ✦ Final Surveys this summer,
- ✦ Cap placement next year,
- ✦ Closeout in 2008,
- ✦ Participatory process with DOE, NRC,
Licensee and CDPHE,
 - ✦ VERY productive.



Cotter/Canon City

- ✦ License in timely renewal since 2000,
- ✦ Revised application 09/2003,
- ✦ License issued 12/2004,
- ✦ Over 50 conditions challenged,
- ✦ Negotiated most away,
- ✦ Went to hearing on 5 issues,
- ✦ Judge agreed with Department on major issues,
- ✦ One condition still challenged (Direct Disposal).

Cotter/Canon City (cont.)

- ✦ Incidents and violations led to Compliance Order,
- ✦ Cotter in standby as of March 2006,
- ✦ Order on Consent in place,
- ✦ No receipt or processing of materials while in standby,
- ✦ Bench scale testing allowed,
- ✦ Engineering evaluation in process,
- ✦ Improved gw monitoring for leak detection.

Cotter/Canon City (cont).

✦ Zirconium pilot plant may ramp up first,

✦ Sequoyah MAR:

- ✦ Issues surrounding characterization of material,
- ✦ Can't receive until readiness review complete,
- ✦ Not approved,

✦ Improved relationship.

Clean Harbors Deer Trail Facility

- ✦ Permit modification for NORM/TENORM,
 - Appealed by County
 - Portions of permit stayed during appeal
- ✦ License application for NORM/TENORM,
 - Appealed by County
 - Appeal dismissed in Denver District Court.
- ✦ Rocky Mountain Low-Level Waste Disposal Compact
 - Compact designation received for radium processing wastes
 - Compact claims jurisdiction over all NORM/TENORM materials

Clean Harbors Deer Trail Facility

✦ Graded approach to application

- Full LLW process not done

✦ Ra-226 < 400 pCi/g

✦ U and Th up to 0.05%,

✦ 2 nCi/g total activity

✦ No LLW or byproduct material by definition.

TENORM

-
- ✦ Drinking water residuals main issue,
 - ✦ Some tailings sites,
 - ✦ Historic practice – case by case basis
 - ✦ New DW standards expands the universe of TENORM generators
 - ✦ Year-Long Stakeholder process to develop guidance and to institutionalize approach,
 - ✦ NRC rulemaking now underway for uranium.
