DATE: June 27 - 28, 2006

TIME: 8:30 a.m. to 4:30 p.m.

PLACE: Four Points Sheraton Denver Cherry Creek, Denver, Colorado

PURPOSE: Transfer information among Nuclear Regulatory Commission (NRC) staff, other Federal agencies, State agencies, and members of the uranium recovery industry.

BACKGROUND:

This meeting was the annual NRC/NMA Uranium Recovery Workshop that provides an opportunity for Federal and State regulators and members of the uranium recovery industry to share information regarding policy, regulatory, and industry issues.

DISCUSSION:

The workshop consisted of a series of presentations by NRC staff, Federal and State regulators, and the uranium industry regarding a broad range of topics, including the NRC staff and organizational issues, the uranium market, NRC's licensing process, ground water sampling and analysis, and discussions of various ISL and conventional mill projects.
