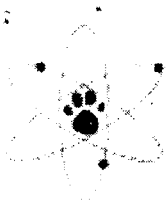

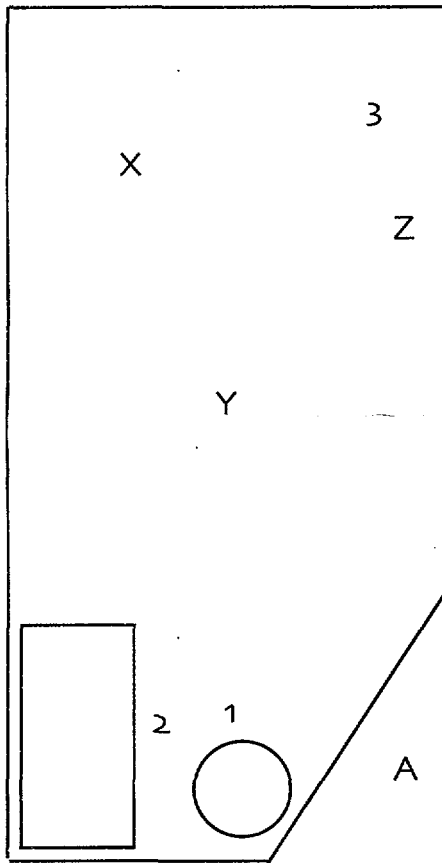

### Procedure Notes

- All radioactive waste and contaminated equipment was removed from the facility prior to the final surveys.
- Only <sup>131</sup>I has been used in this facility; the well counter was calibrated immediately prior to use.
- Standard cleaning procedures were used to decontaminate the treatment room prior to wipe tests.
- Wipe tests within the treatment room were performed on a 100cm<sup>2</sup> area for each test.
- Wipe tests in unrestricted use areas were performed on multiple representative sites throughout the room, and a cumulative reading was used.
- A survey meter was used to check for any readings above background in all public and restricted areas. There were no elevated levels in any public or restricted area.
