I also related to Mr. Mickelson, regarding any future change of ownership transactions, that current guidance to be followed is found in Appendix F of NUREG-1556, Vol. 15 (November 2000), rather than Information Notice 89-25, Rev. 1, Attachment 1 (December 7, 1994). Further I noted that the current guidance document states that the licensee is to obtain NRC's "prior written consent" before transferring control of the license.
- 4. Item 13 of the licensee's letter dated April 4, 2006, refers to an "attached certificate" whereby the transferee, SG Solutions, LLC, agrees to full responsibility for the site. The referenced certificate was not attached to the letter we received. Please provide a copy for our review/evaluation.
