**NOTICE OF WILLIAM STEIN'S PETITION FOR RULEMAKING FOR COMMENT  
(STP-06- 061)**

**Purpose:** To inform the Agreement States regarding William Stein's petition for rulemaking.

**Background:** The U.S. Nuclear Regulatory Commission (NRC) has received and requested public comment on a petition for rulemaking filed by William Stein III, M.D. (petitioner). The petition has been docketed by the NRC and has been assigned Docket No. PRM-35-19. The petitioner is requesting that the NRC amend the regulations that govern medical use of byproduct material concerning training for parenteral administration of certain radioactive drugs used to treat cancer.
