The purpose of this modification is to: (1) increase the number of "Strategic Planning Meetings" by 150 sessions from 280 to 430, (2) increase the ceiling by \$185,625.00 from \$608,774.00 to \$794,399.00, and (3) provide incremental funding in the amount of \$53,000 hereby increasing the obligated amount from \$359,000 to \$412,000. Accordingly, the contract is hereby modified as follows:

1) Under Section B.1, Price/Cost Schedule, Task V, the number of Strategic Planning Meetings is changes by 150 from 280 to 430 as follows:

2) The ceiling amount of this order is changed to \$794,399.00.

3) Under Section B.1.1.b, "consideration and Obligation Delivery Order (June 1988)" the first sentence is hereby revised to read as follows:

"b. The amount presently obligated with respect to this contract is \$412,000.00."
