

The purpose of this modification is to: 1) exercise option year 2 in accordance with Section I.6, B.1 and B.2, hereby increasing the estimated ceiling amount by \$568,789 from \$1,114,384 to \$1,683,173, and 2) extend the period of performance through September 29, 2007. Accordingly, the contract is hereby modified as follows:

In accordance with Section I.6, Option to Extend the Term of the Contract, the NRC hereby exercises the second option year in accordance with the prices in Section B.1, Option Year 2, and paragraph (d) of Section B.2.

Section F.2, Duration of Contract Period, is revised as follows:

*"The ordering period for this contract shall commence on October 1, 2004 and will expire on September 29, 2007. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering). The term of this contract may be extended at option of the Government for an additional 2 one-year options."*

All other terms and conditions remain unchanged.
