

The purpose of this modification is to 1) exercise Option Year 4 of the contract, thereby extending the period of performance of the contract from August 23, 2006 to August 22, 2007 2) increase the ceiling amount of the contract by \$196,536.00 from \$468,691.50.00 to \$665,227.50 3) increase the amount obligated by \$13,000.00 from \$455,392.00 to \$468,392.00. Accordingly, the contract is modified as follows:

1) Subsection B.2, CONSIDERATION AND OBLIGATION, paragraphs (a) and (b), are deleted in their entirety and substituted with the following in lieu thereof:

“(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered and accepted under this contract is \$665,277.50.”

“(b) The amount presently obligated with respect to this contract is \$468,392.00.”

2) Subsection B.5, DURATION OF CONTRACT PERIOD, delete paragraph in its entirety and substitute with the following in lieu thereof:

“This contract shall commence on August 23, 2002 and will expire on August 22, 2007.”

A summary of obligations from the date of award through the date of this action is provided as follows:

This modification obligates FY06 funds in the amount of \$13,000.00.

All other terms and conditions of the subject contract remain unchanged.
