
The purpose of this letter is to request Amendment No. 3 to License #37-30652-01 held by CDS Properties, LLC. The amendment is being requested to allow the inclusion of a nuclear density / moisture content gauge manufactured by CPN International, Inc.

The current Amendment No 2 to our license lists Cesium 137 and Americium 241 sealed sources referencing Troxler Drawing No. A-102112 (Cesium 137) and Troxler Drawing Nos. A-102451 or A-102113 (Americium 241:Be). The maximum activity for the referenced Troxler drawings are 333 MBq or 9 mCi (Cs-137) and 1.63 GBq or 44 mCi (Am-241:Be).

We wish to amend our license to include the use of a CPN International, Inc. Portaprobe, MC-Series gauge. This gauge has the following sources and activities: Cesium 137, 370 MBq (10 mCi) and Americium 241/Be, 1.85 GBq (50 mCi) sealed sources. Therefore, we would like to change our source and possession limit to include the CPN International, Inc. Source Model No. CPN-131 with possession limits of 10 mCi or 370 MBq (Cs-137) and 50mCi or 1.8 GBq (Am-241) per gauge. The authorized use remains unchanged except that CPN MC Series portable gauges should also be included in the description.
