SUBJECT SUMMARY OF JULY 13, 2006, MEETING WITH ENERGY SOLUTIONS  
TO DISCUSS IMPLEMENTATION OF AMENDMENTS

On July 13, 2006, representatives from EnergySolutions and Part 72 general licensees, from Entergy - Arkansas Nuclear One (ANO), and Nuclear Management Company (NMC) - Palisades, met with staff of the U.S. Nuclear Regulatory Commission (NRC). A list of attendees is enclosed (Enclosure 1). EnergySolutions discussed its concerns about implementing changes to Certificates of Compliance (CoC) issued under 10 CFR Part 72. In particular, EnergySolutions remarked upon the recent Amendment 6 to the VSC-24 cask system in which the thermal monitoring requirements were revised. EnergySolutions in its presentation to staff (Enclosure 2), pointed out that there was no clear guidance for cask systems that have been loaded under earlier amendments regarding implementation of the newer requirements. In the case of the VSC-24, the currently loaded casks would benefit from the changes to the technical specifications associated with thermal monitoring in the most recent amendment.

The staff noted issues discussed by general licensees regarding implementation of changes associated with Amendment No. 6 to CoC 72-1007. Possible solutions for addressing the concerns of the CoC holders and the general licensees were proposed.

Action Items:

ANO requested guidance on the method that it should consider for revision of its thermal monitoring system. NRC staff will contact EnergySolutions regarding its users immediate need. In addition, the staff will pursue this matter for further consideration.
