Operational Status

Indian Point Unit 2 is operating at 100% and has been on line 34 days.
Indian Point Unit 3 is operating at 100% reactor power and has been on-line for 182 days.

Groundwater Investigation

Update on Phase 2 wells

Entergy has completed the installation of 23 new monitoring wells to characterize the flow of groundwater on site.

Most of the phase 2 wells have been sampled. There are no detectable or trace levels of tritium except adjacent to the discharge canal and next to the IP1 Fuel Building. The following table summarizes the sample results for the wells that have sample results:
