


The purpose of this modification is to: 1) Correct a typographical error made in Modification No. 1, 2) Exercise Option Year One to extend the period of performance of the contract from May 10, 2006 through May 9, 2007; 3) Increase the ceiling amount of the contract by \$231,938.00 from \$216,828.00 to \$448,766.00; 4) Add incremental funding in the amount of \$219,900.00, thereby increasing the amount obligated in the contract from \$175,000.00 to \$394,900.00; and 5) Add key personnel to the contract. Accordingly, the subject contract is hereby modified:

1. Modification No. 1, Block 14, first paragraph beginning with "The purpose of this . . .," last sentence, is deleted and substituted with the following in lieu thereof:

"These funds will increase the obligated amount from \$100,000.00 to \$175,000.00."

2. Section B.2 CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), paragraph (a), first sentence, is deleted and substituted with the following in lieu thereof:

"The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$448,766.00."

3. Section B.2 CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), paragraph (b), first sentence, is deleted and substituted with the following in lieu thereof:

"The amount presently obligated with respect to this contract is \$394,000.00."

4. Section XI. Period of Performance, is deleted and substituted with the following in lieu thereof:

"The period of performance shall be from May 10, 2005 through May 9, 2007. The term of this contract may be extended an addition three years."

5. Section C.6 KEY PERSONNEL, paragraph (a) is deleted in its entirety and substituted with the following in lieu thereof:
