The purpose of this modification is to exercise option year one in accordance with Federal Acquisition Regulation Clause 52-217-9, entitled, "Option to Extend the Term of the Contract," and Contract Clause F.6, entitled, "Duration of Contract Period," thereby extending the contract period of performance through June 19, 2007. As a result of this action, the contract ceiling amount is increased by \$159,442.00 from \$152,769.00 to \$312.211.00.

Accordingly, the following changes are hereby made:

1. Under Subsection B.3, <u>Consideration and Obligation–Task Orders</u>, Paragraph a is deleted in its entirety and substituted with the following in lieu thereof:

"(a) The total estimated amount of this contract (ceiling) for the products/services, ordered, delivered and accepted under this contract is \$312.211.00. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are with any maximum ordering limitation prescribed under this contract."

2. Subsection F.6, <u>Duration of Contract Period</u>, is deleted in its entirety and substituted with the following in lieu thereof:

"The ordering period for this contract shall commence on June 20, 2005, and will expire on June 19, 2007. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18). The term of this contract may be extended at the option of the Government for an additional 3 one-year periods."

There is no funding activity for this modification.

All other terms and conditions under this contract remains unchanged.
