


The purpose of this modification is to deobligate funds in the amount of (\$473.19) thereby reducing the amount obligated from \$114,650.00 to \$114,176.81. Accordingly, the contract is modified as follows:  Refer to section B.1, "CONSIDERATION AND OBLIGATION &C" DELIVERY ORDERS (JUNE 1988)" paragraph (b) first sentence is deleted in its entirety and replaced with the following in lieu thereof: "b) The amount presently obligated with respect to this contract is \$114,176.81"  All other terms and conditions remain the same.
