## B.8 SUMMARY OF DELIVERABLES:

1. The contractor shall submit all deliverables in paper copy and in electronic format in either WP 10.0 or WinWord Version XP on 3.5" floppy diskette or CD-ROM and are due at the timeframes outlined below. Deliverables will be reviewed and signed off by the Project Officer.

### 2. STE Plan

The STE Plan shall identify all testing assumptions, constraints, and dependencies and include a proposed schedule that identifies which personnel, hardware, software, and other requirements that must be met for each portion of the schedule to accomplish full system security testing of all systems security functional and assurance requirements where the requirements are not stated as being fulfilled by another system

a) Draft STE Plan - Due within 35 calendar days of contract expiration. The NRC Project Officer shall review the draft STE Plan and provide written comments if necessary within 5 days.

b) Final STE Plan - Due within 20 calendar days from receipt of draft comments from the NRC Project Officer. The Contractor shall incorporate the NRC Project Officer's comments in the final plan.

Acceptance Criteria: The Data Center/ Telecommunications system STE Plan shall be developed in accordance with NIST SP 800-53 "Recommended Security Controls for Federal Information Systems," NIST SP 800-37 "Guide for the Security Certification and Accreditation of Federal Information Systems," and the NRC System Security Test and Evaluation Plan Template.

### 3. STE Test

The contractor shall test the data center against the approved System Security Test and Evaluation Plan (STE Plan) using the detailed and approved STE Plan's test procedures and document the testing in a System Security Test and Evaluation Report (STE Report).

Due within 15 calendar days of contract expiration.

Acceptance Criteria: The ST&E test shall follow the approved ST&E Plan and functions of the current data center security and management controls and identify any weaknesses.

### 4. STE Test Report

The STE Report shall identify all testing assumptions, constraints, and dependencies as well as any anomalies, impromptu tests, and deviations encountered during testing. The STE Report shall include the actual testing schedule and detailed test results for each test procedure outlining specific errors encountered. The STE Report shall include a summary of the system scans and a table of test findings incorporating any test issues and recommendations. The STE Report shall identify any requirements that have not been met and identify the resulting impact to the system.

a) Draft STE Report - Due within 10 calendar days of contract expiration. The NRC Project Officer will review the Draft STE Report and provide written comments if necessary within 5 days.

b) Final STE Report - Due within 5 *calendar days* from receipt of draft comments from NRC Project Officer. The Contractor shall incorporate the NRC Project Officer's comments in the final STE Report.

Acceptance Criteria: Quality, Accuracy and timeliness of Report. The Data Center/ Telecommunications system STE Report shall be developed in accordance with NIST SP 800-53 "Recommended Security Controls for Federal Information Systems," NIST SP 800-37 "Guide for the Security Certification and Accreditation of Federal Information Systems," and the NRC System Security Test and Evaluation Plan Template.
