The only radiopharmaceutical used in the old department was Technetium-99m with a half-life of 6 hours.

Cs-137, Ba-133 and Co-57 sealed sources for equipment testing were used in the department. These sources were leak tested on 05/04/06. A copy of the leak test results is enclosed for your review.

This facility has no history of any leaking sources.

Wipe tests were analyzed with a Ludlum Well Counter

Surveys were performed using a Ludlum 14C GM survey meter with an end window probe. The meter was last calibrated on 01/03/06. Range used was 0-0.2 mR/hr.

Visual Check

The area was checked to ensure that all radioactive materials had been removed.

Radiation Level Survey

No area within the room demonstrated radiation levels in excess of the background reading of _0.2 mSv/hr (0.02 mR/hr).
