9. DESCRIPTION OF MODIFICATION

The purpose of this modification is to deobligate fiscal year 2001 unexpended funds in the amount of \$83.00 from the interagency agreement; change the status of the agreement from closed to active status since it was closed out by mistake on March 31, 2006, and to extend the period of performance retroactive from October 1, 2005 through September 30, 2007. Except as provided herein, all other terms and conditions of the agreement remain in full force and effect.

The purpose of this modification is to (1) Reinstate the agreement to active status, as it was erroneously closed out via letters dated March 31, 2006; 2) Extend the period of performance of the interagency agreement through September 30, 2007, to provide for continued services; and deobligate fiscal year 2002 funds in the amount of \$83.00 under Job Code R2001, hereby decreasing the net total funds obligated under this agreement by \$83.00 from \$1,846,346.00 to \$1,846,263.00. Accordingly, the following changes are hereby made to this agreement:

1. Article II - Period of Performance, the first sentence is revised to read as follows:

"The period of this Interagency Agreement shall be from March 1, 1990 through September 30, 2007."

2. Article V - Obligation of Funds and Estimated Amount, second sentence, is deleted in its entirety and the following is substituted in lieu thereof:

"The amount presently obligated under this Agreement is \$1,846,263.00."
