

The purpose of this modification is to: (1) exercise Option Year 1 (February 15, 2006 – February 14, 2007), thereby extending the expiration date from February 14, 2006 to February 14, 2007. (2) increase the ceiling amount of the delivery order by \$19,875.20 from \$22,800.00 to \$42,675.20 (3) obligate funds in the amount of \$11,000.00 thereby increasing the obligated amount of the delivery order from \$22,800.00 to \$33,800.00. Accordingly, the following changes are hereby made:

1. Under Optional Form 347, Block 17 – SCHEDULE, is hereby amended to revise the period of performance to the subject delivery order as a result of the NRC exercising the first option year.

2. Under Paragraph A.6 – CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), the first sentence of Subparagraph (a) and (b) are hereby deleted in their entirety and substituted in lieu thereof.

"(a) The total estimated amount of this delivery order (ceiling) for the products/services ordered, delivered, and accepted under this delivery order is \$42,675.20"

"(b) The amount presently obligated with respect to this delivery order is \$33,800.00"
