Subject: Change in Governor's Designee for the State of Minnesota

Ms. Virgilio: A couple of months ago I received the annual letter from Ms. Janet Schlueter, Director of the Nuclear Regulatory Commission's Office of State and Tribal Programs, enquiring as to whether or not there has been any change in the Governor's Designee information for the State of Minnesota. In her letter, Ms. Schlueter requested that notification of any such changes be forwarded to you no later than May 31, 2006. In response to this request, I would like to inform you that, effective April 3, 2006, Mr. Kevin Leuer, of this agency, was appointed by Governor Pawlenty to be my successor as Governor's Designee. (This information was previously conveyed to Ms. Schlueter, via a March 6, 2006 letter from Governor Pawlenty.) Mr. Leuer is also the designated State of Minnesota official "...to receive advance notifications of other shipments of certain radioactive materials from NRC and Agreement State licensees as part of the enhanced security measures issued by the NRC following the terrorist events of September 11, 2001."



You are also the designated State official to receive advance notifications of other shipments of certain radioactive materials from NRC and Agreement State licensees as part of the enhanced security measures issued by the NRC following the terrorist events of September 11, 2001. I have enclosed a copy of the applicable portions of the regulations for your information. Also enclosed is a copy of NUREG-0794, "Protection of Unclassified Safeguards Information," which is intended to assist persons who possess Safeguards Information in establishing an information protection system that satisfies the specific requirements of Section 73.21 of Part 73.

I have also enclosed a copy of the present list of Governors' designees, containing your address and telephone number. If any information on this list is inaccurate, please send your corrections to the Office of State and Tribal Programs. If we do not receive a response by **May 31, 2005**, we will assume the information shown on the list is correct. The list of Governors' designees is required to be published in the Federal Register on or about June 30, 2005.

In the aftermath of the events of September 11, 2001, we have recognized the importance of being able to communicate information to States quickly. The Office of State and Tribal Programs uses an E-mail distribution system to provide information to the Governor-appointed State Liaison Officers and State Radiation Control Program Directors. We would like to create a similar dedicated list server for Governors' designees in order to provide you with non-safeguards information electronically. We request that you provide us with an E-mail address so that we may provide this information to you in a more expedited fashion. We will not publish your E-mail address in the Federal Register, but will have it available to provide you information in a more timely fashion than the regular mail service.


