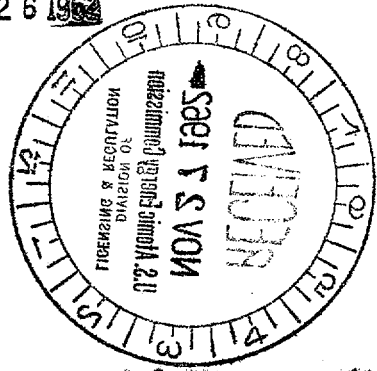

Reference is made to your recent letter regarding CISE's purchase of nuclear fuel manufacturing facilities from Engelhard Industries, Inc. The 13 grams of U-235 which is embedded and unrecoverable in the equipment is covered by the enclosed sale contract (IT/2/29) between the United States and Italy pursuant to the Agreement for Cooperation.

Upon receipt of the signed contract, we will authorize Engelhard to export the subject equipment. It is understood that the export of this equipment to Italy will be subject to all terms and conditions of the Agreement for Cooperation.
