3) Transportation and Route Schedule

The vessel sailed from Adelaide, Australia on August 29, 2003. The ocean transportation from Adelaide, Australia to Vancouver, British Columbia, Canada will be the responsibility of Columbus Steamship Line. The vessel will unload at Vancouver, British Columbia, Canada on September 25, 2003. The containers will then be loaded onto the rail for importation to Ranier, MN.
