### 3) Transportation and Route Schedule

The vessel sailed from Adelaide, Australia on September 12, 2003. The ocean transportation from Adelaide, Australia to Vancouver, British Columbia, Canada will be the responsibility of Columbus Steamship Line. The vessel will unload at Vancouver, British Columbia, Canada on October 9, 2003. The containers will then be loaded onto the rail for importation to Ranier, MN. The containers will enter the USA at Ranier, MN on/about October 15, 2003, and will continue on rail to St. Louis, MO.
