Dear Mr. Toelle:

In accordance with your amendment request dated June 2, 2006 (AET 06-0067), and pursuant to Part 70 to Title 10 of the *Code of Federal Regulations*, the fire protection changes requested for the American Centrifuge Lead Cascade Facility (Lead Cascade) are hereby approved. However, the staff determined that an amendment to Material License SNM-7003 was not required, as all conditions of this license shall remain the same. Nevertheless, approval of the changes to the Integrated Safety Analysis Summary was necessary and the proposed revision to the referenced item relied on for safety is approved.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(16).

Enclosed is a copy of the Safety Evaluation Report, which includes the Categorical Exclusion. In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the
