SUBJECT: ISSUANCE OF ORDER IMPOSING FINGERPRINTING AND CRIMINAL
HISTORY CHECK REQUIREMENTS FOR ACCESS TO SAFEGUARDS
INFORMATION

Dear Dr. Vernetson:

The U.S. Nuclear Regulatory Commission (NRC or Commission) has issued the enclosed Order (Enclosure 1) imposing additional requirements on access to certain Safeguards Information (SGI). On August 8, 2005, the President signed into law the Energy Policy Act of 2005 (EPAAct). The EPAAct amended the Atomic Energy Act (AEA) of 1954 to require fingerprinting and a Federal Bureau of Investigation (FBI) identification and criminal history records check of any person permitted access to new SGI as described in the attached Order.

The NRC has taken this action because it will provide new SGI to you to ensure adequate protection of your facility and associated special nuclear material. Under Section 147 of the Atomic Energy Act of 1954, as amended, the Commission has authority to "issue such orders, as necessary to prohibit the unauthorized disclosure of safeguards information...." The Order directs you not to share new SGI as described in the attached Order with any recipient unless that person has a need to know the SGI, has been fingerprinted and undergone a FBI identification and criminal history records check, the fingerprint check has been favorably decided, and has satisfied all other applicable requirements for access to SGI. Fingerprinting and the FBI identification and criminal history records check are not required, however, for any person who is relieved from that requirement by 10 CFR § 73.59 or has an active federal security clearance. Individuals who currently have access to existing SGI may continue to have access to all SGI except the new SGI without undergoing fingerprinting. This Order is effective immediately and imposes requirements in addition to other applicable requirements for access to SGI.

It is the staff's understanding that to ensure adequate protection of your facility and associated special nuclear material, you may need to share this SGI with individuals that meet the above criteria. The Order also directs you to provide a copy of this Order to such individuals. By doing so you are informing these individuals that this Order also applies to them. Unauthorized disclosure of SGI may result in civil or criminal penalties.
